#### 6' PORTABLE PICNIC TABLE WALK-THROUGH DESIGN

Top & Seats: No. 1 Southern Yellow Pine stained with a redwood stain wood preservative.

Frame: 2-3/8" O.D. x 12 gauge pre-galvanized structural steel tubing. One 1 1/2" x 3/4" x 1/8" center channel shall be mechanically attached to the bottom side of tabletop to prevent warping of wood and to attach cross braces, thus providing over all strength and rigidity. Cross braces 1 5/16" O.D. x 15 gauge pre-galvanized structural steel tubing. Brace attachment points 1-1/2"x1-1/2"x3/16" steel angle. All tabletop and seat mounting brackets shall be precision punched and fabricated from 2" x 2" x 7 gauge formed angle. Legs are bent over a mandrel through the bend radius producing a wrinkle free bend. All electrically MIG welded.

Frame Coating: Electrostatic powder coated application oven cured or hot dipped galvanized.

Hardware: Hardware shall be hot-dipped galvanized.

Dimensions: 6' portable picnic table walk-through design. Top is 27-3/4" wide x 72" long and is 30" high. Seats are 9-1/4" wide x 72" long and 18" high. Outside to outside dimension is 65" x 72".






Attach the Wood Planks and the Center C-Channel to the 238 Frames as shown using specified hardware. Note that the center bolt is between the C-Channel and the table plank.




Attach the Wood Braces to the C-Channel and the 238 Frames as shown using specified hardware.


Attach the Wood Seat to the 238 Frames as shown using specified hardware.

#### 238-U6IC TABLE WALK-THROUGH DESIGN

Top & Seats: No. 1 Southern Yellow Pine.

Frame: 2-3/8" O.D. x 12 gauge pre-galvanized structural steel tubing. One 1 1/2" x 3/4" x 1/8" center channel shall be mechanically attached to the bottom side of tabletop to prevent warping of wood and to attach cross braces, thus providing over all strength and rigidity. Cross braces 1 5/16" O.D. x 15 gauge pre-galvanized structural steel tubing. Brace attachment points 1-1/2"x1-1/2"x3/16" steel angle. All tabletop and seat mounting brackets shall be precision punched and fabricated from 2" x 2" x 7 gauge formed angle. Legs are bent over a mandrel through the bend radius producing a wrinkle free bend. All electrically MIG welded.

Frame Coating: Electrostatic powder coated application oven cured or hot dipped galvanized.

Hardware: Hardware shall be hot-dipped galvanized.

Dimensions: 6' portable picnic table walk-through design. Top is 27-3/4" wide x 72" long and is 30" high. Seats are 9-1/4" wide x 72" long and 18" high. Outside to outside dimension is 65" x 72".






Attach the Wood Planks and the Center C-Channel to the 238 Frames as shown using specified hardware. Note that the center bolt is between the C-Channel and the table plank.




Attach the Wood Braces to the C-Channel and the 238 Frames as shown using specified hardware.


Attach the Wood Seat to the 238 Frames as shown using specified hardware.
