

WARRANTY The Park Catalog will warrant its products against defects in workmanship and materials for a period of (12) months for all products consisting of TGIC powder coat or stainless steel finishes, for a period of two years for PVC rubber dip over galvanized finishes, and for a period of five years on products consisting of a galvanized finish. Under this warranty, The Park Catalog's liability is limited to repair or replacement, at The Park Catalog's option, of products found in The Park Catalog's reasonable judgment to have been defective in workmanship or materials.

For the Ultra Space Saver Squared product there is interior and exterior grade powder coat. For interior grade, the product must be installed in an interior location not exposed to the elements. For parking garages, they must be 20' from exposure.

This warranty does not cover failure due to negligence, abuse, vandalism, accidents, lack of maintenance, or improper installation; nor does it cover defects or failure due to products tampered with, altered, modified, or repaired by anyone not approved by The Park Catalog. In addition, The Park Catalog will not warranty powder coated and 304 grade stainless steel shelter products within 1/2 mile of saltwater bodies. In this situation we recommend galvanized or powder coat over galvanized.

The The Park Catalog Air Kit 4 and Air Kit Prime are warranted for temperatures ranging from -30 – 110 degrees. There is a one year warranty period for the pump, parts and gaskets, and a six-month warranty on the hose and pump head. Acts of God, improper use or vandalism are not covered by this warranty.

The Park Catalog will warrant against defects in workmanship and materials for a period of (12) months from the date of delivery. Under this warranty, The Park Catalog's liability is limited to repair or replacement, at The Park Catalog's option, of products found in The Park Catalog's reasonable judgment to have been defective in workmanship or materials. This warranty does not cover failure due to negligence, abuse, vandalism, accidents, lack of maintenance, or improper installation; nor does it cover defects or failure due to products tampered with, altered, modified or repaired by anyone not approved by The Park Catalog.

The Park Catalog will assume transportation charges for return of the defective product if returned by the buyer in accordance with written instructions from The Park Catalog. The Park Catalog will not be responsible for providing the cost of labor for removal or installation of the defective product or any replacement. In no event shall The Park Catalog be liable for special, inherent or consequential damages, including, without limitation, loss of use or profits.

Proof of sale from The Park Catalog is required. The foregoing warranty is exclusive and is given and accepted in lieu of any and all other warranties, expressed or implied, including, without limitation, the implied warranties of merchantability and fitness. The remedies of buyer for any breach of warranty shall be limited to those provided herein. No agreement varying or extending the foregoing warranty will be binding upon The Park Catalog unless it is in writing and signed by a duly authorized officer of The Park Catalog.
