



5-YEAR LIMITED WARRANTY

WHAT IS COVERED

Highland warrants the original purchaser/end-user, and not any other purchaser/end-user that its Pro-Knit™, Pro-Block™, Signature™, Premier™ Vinyl and Commercial fabrics shall be free from defects in material and workmanship including rotting/degradation for a period of five (5) years and will be prorated as indicated in “Warranty Protection Schedule” below.

WHAT IS NOT COVERED

Damage from abnormal or improper use, improper application or design, accident, alteration, neglect, abuse, air pollutants, improper service or installation, or damage caused by flood, fire, or act of God is not covered by this limited warranty.

HOW TO MAKE A CLAIM

The purchaser/end-user must promptly notify Highland in writing of any defect and provide proof of the date of purchase. Highland will then investigate the claim, and if a defect covered by this warranty is confirmed, will pay to repair or replace the defective product under the terms of this limited warranty.

CONDITIONS AND EXCLUSIONS

THE AMOUNT OF YOUR RESTITUTION WILL NOT INCLUDE LABOR TO INSTALL THE REPLACEMENT MATERIALS, DELIVERY, SALES TAX OR ANY OTHER CHARGES, NOR IS HIGHLAND REQUIRED TO PROVIDE SUCH LABOR OR SERVICE.

THIS LIMITED WARRANTY IS IN LIEU OF ALL OTHER EXPRESS WARRANTIES. HIGHLAND MAKES NO OTHER EXPRESS WARRANTIES, AND DOES NOT AUTHORIZE ANY OTHER PERSON OR AGENT TO MAKE ANY OTHER EXPRESS WARRANTIES. HIGHLAND NEITHER ASSUMES NOR AUTHORIZES ANY OTHER LIABILITY OR OBLIGATION IN CONNECTION WITH THESE PRODUCTS. EXCEPT TO THE EXTENT PROHIBITED BY APPLICABLE LAW, ANY IMPLIED WARRANTY, INCLUDING WITHOUT LIMITATION, THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE WITH THE RESPECT TO THESE PRODUCTS, IS LIMITED IN DURATION TO THE FIVE (5) YEAR TERM OF THIS LIMITED WARRANTY.
